

Why Should I Give?

As Christians we are called to respond to God's amazing grace, the undeserved gift of his Son for us, by giving.

Generous giving blesses others and supplies the needs of God's people. It is also an act of obedience and trust - in doing it we are saying that it is God, not ourselves or anyone else, who ultimately provides for our needs.

Giving should never be forced or grudging, but rather voluntary and cheerful.

Regular Giving By Standing Order

Giving monthly by standing order is the most helpful way of supporting the ministry at St. Andrew's. It allows us to budget intelligently and to manage our cash flow more efficiently. This is administered for us free of charge by the Parish Giving Scheme.

One-Off Gifts

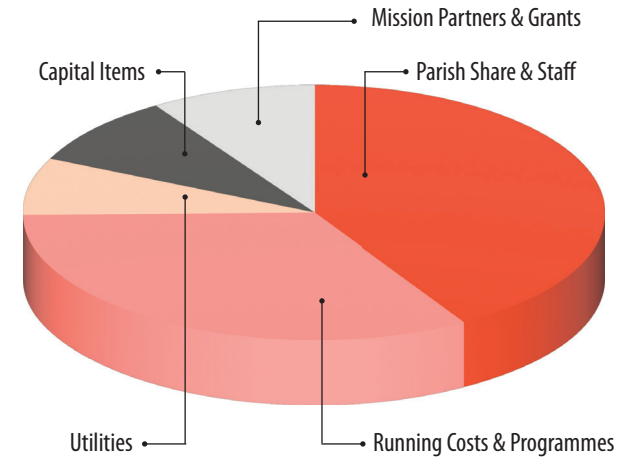
- Make a bank transfer directly to our account.

- Use your debit or credit card on the touch-screens at church. Designed for modest/casual giving, this route will incur charges for us and will not typically allow us to reclaim Gift Aid.
- Place cash or cheques in the collection box at church. Cheques should be made out to St Andrew's PCC.

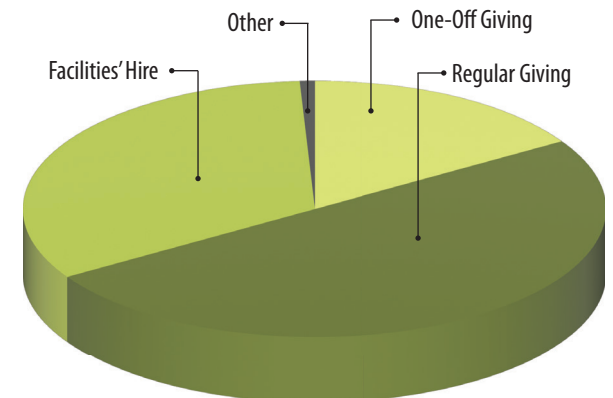
How do we spend our money?

It cost £1,730 a week during 2021 to run the ministry at St. Andrew's and to support our mission partners.



How are we funded?

As shown below, almost three quarters of our income in 2021 came from members of our fellowship giving generously and sacrificially. Renting our facilities to third parties provided a welcome boost, though the level of contribution made in 2021 is unlikely to be repeated in the near future.



giftaid it

If you are an eligible UK taxpayer you can make your gift go a whole lot further.

As long as you will have paid at least as much in income or capital gains tax as you give to charities under the scheme, the tax-man will return the basic rate tax he has already taken, giving it directly to your chosen beneficiary.

You will need to sign a Gift-Aid declaration to enable this. This is best done online at www.standrewswimbledon.com/give. Regular donations made through the Parish Giving Scheme will require a separate declaration which you can complete when you register for the scheme.

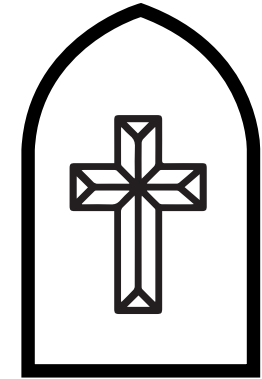
Higher-rate taxpayers can then reclaim additional tax directly by submitting a self-assessment tax return. Some givers choose to pass this on to the causes they support.
